Sub: Doubling of quantum of compensation fixed under Family Planning Indemnity Scheme (FPIS)

In pursuance of Govt of India letter vide D.O.No: N-11017/C/2012-FP.II (Part II) Dt. 21st January 2019 and as per the directives of the Hon'ble Supreme Court of India, it is hereby notified that the quantum of compensation under Family Planning Indemnity Scheme (FPIS) will be doubled and the burden thereof to be borne equally by the Government of India and the State Government.

The benefits under Planning Indemnity Scheme (FPIS) shall be as under with immediate effect:
